

To trust or not to trust: Opportunities and risks in International Estate Planning

This Working session will analyze both opportunities and problems connected with international estate planning structures established by private clients, both from a legal and tax perspective. We will particularly focus on a comparative analysis of different legal systems in terms of estate planning instruments available, with particular attention on trusts, as well as in terms of legal/public policy limitations to an effective estate planning scheme. We will also discuss conflict of laws and jurisdiction issues and harmonization issues. Related to tax, presumed tax avoidance that might be invoked in relation to trusts and foundations will be analyzed, as well as the tax authorities' reply to that. The clear and apparent differences that exist in the possibility to make use of trusts from a legal perspective in comparison to a tax perspective will be closely analyzed and commented by the various national reporters which will include both civil law as common law countries.
